












Reservoir Work

- Work through local USACE
 Project Office
- Coordinate with State Fish and Wildlife Management Agency

Most common projects:
 Shoreline stabilization (USACE provides materials, equipment and labor)

Partners provide funding for habitat restoration in conjunction with the shoreline restoration work

Funding supports the establishment or further development of watershed groups to address water quantity and quality issues in the West








Cost sharing for fish and wildlife enhancement facilities


- 75:25 for habitat work

NFWF focuses on several approaches to restore and maintain freshwater species and their habitats:

- Passage: Eliminate barriers to fish movement
- Water quality: Reduce pollution to restore clean water
- Water quantity: Ensure that stream flows are maintained at healthy levels
- Spring systems: Protect springs and other unique ecosystems for freshwater species
- Control of invasive species: Restore the natural balance of the ecosystem
